Ople Center, POEA, and LGUs Join Forces in Fight Against Trafficking through Memorandum of Understanding

On February 2, 8, and 10, 2022, the Ople Center, in partnership with the Philippine Overseas Employment Administration (POEA) and the Local Government Units (LGUs) of Calatagan, Cabuyao, and Pateros, took a significant step forward in the battle against trafficking by signing a Memorandum of Understanding (MOU). The MOU's signing marked a united effort to bolster Anti-Illegal Recruitment and Anti-Trafficking in Person Campaigns.

This groundbreaking MOU, endorsed by all participating parties, seeks to reinforce the information campaign on national policies, as well as programs and services accessible to the public and migrant workers. It places a particular emphasis on welfare services, anti-illegal recruitment, anti-trafficking in persons, skills training, reintegration, and public information and education.

The core objective of this initiative is to empower the public, migrant workers, and their families by providing access to online modules that educate them about their rights, as well as the programs and services extended by the Philippine government. This inclusive approach aims to raise awareness and equip individuals with the knowledge they need to protect themselves and others from illegal recruitment and trafficking.

The MOU's signing signifies a critical step towards eradicating trafficking and enhancing the safety and well-being of migrant workers and their families. It demonstrates a unified commitment to the cause, bringing together government agencies, non-governmental organizations, and local authorities in a shared endeavor to combat trafficking and offer a brighter future for all.
